

# ORDINANCE NO 1094

## AN ORDINANCE OF THE CITY OF ROSLYN, WASHINGTON, AMENDING ROSLYN MUNICIPAL CODE SECTION 13.10.400 RELATED TO SEWER SYSTEM DEVELOPMENT FEES

**WHEREAS**, the City of Roslyn is a partner in a regional wastewater treatment facility with the City of Cle Elum and the Suncadia Development Community; and

**WHEREAS**, Suncadia Environmental Company put money up front to build the regional facility known as system development fees; and

**WHEREAS**, an agreement was put in place regarding the operations of the regional facility and repayment of system development fees and interim system development fees were adopted; and

**WHEREAS**, after a recent reconciliation process, a final system development charge has been calculated which requires an amendment to the Roslyn Municipal Code; and

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ROSLYN, WASHINGTON, DO ORDAIN AS FOLLOWS:**

**Section 1. Roslyn Municipal Code Section 13.10.400, Amended.** Section 13.10.400 (Rates and charges) of the Roslyn Municipal Code is hereby amended to read as follows (with legislative revision marks):

### **13.10.400 Rates and charges.**

The following rates and charges are hereby fixed for sewerage service inside and outside the city limits, and shall be paid therefore:

System Development Fee:	\$2,000
Suncadia System Development Repayment Fee:	<del>\$3,900</del> <u>\$3,938</u> (to be paid at the time application for sewer service is submitted)

**Section 2. Severability.** Should any section, paragraph, sentence, clause or phrase of this Ordinance, or its application to any person or circumstance, be declared unconstitutional or otherwise invalid for any reason, or should any portion of this Ordinance be pre-empted by state or federal law or regulation, such decision or pre-emption shall not affect the validity of the remaining portions of this Ordinance or its application to other persons or circumstances.


**Section 4. Effective Date.** This Ordinance shall be published in the official newspaper of the City, and shall take effect and be in full force five (5) days after the date of publication.
