WHEREAS, the agreement may be extended upon mutual consent of both parties; and


WHEREAS, the City desires to extend the contract with Washington Collectors Tri-Cities, Inc.; and

Section 1. The Mayor is authorized to enter into an agreement with Washington Collectors Tri-Cities, Inc. for Municipal Court Collection Services.


